**Base Bid**

The Base Bid shall consist of the surface preparation, cleaning, sealing, caulking, and painting of the District 3 Headquarters Building. All newly installed wood (if applicable) shall be fully primed prior to paint application. Any exposed bare wood on existing surfaces shall be spot primed prior to paint application. Apply a flexible silicon based latex caulk around wood trim and siding joints. Caulking should be performed at the time of carpentry work. Caulking should be a ten-year silicon latex caulk. All carpentry work (if applicable) shall be performed by a skilled carpenter or carpentry crew. Paint all exposed surfaces, including trim, siding, window trim, door trim, and eaves. Allow for furnishing and installing 32 square feet of plywood (thickness, ply, and quality to match existing) to replace any damaged eave areas. The total of all items shall be summarized as the Total Base Bid in the space indicated below.




