#### **INSTRUCTIONS**

- 1. REVIEW DOCUMENTS THOROUGHLY: The attached documents contain a solicitation for bids. Please read these instructions and all documents attached in their entirety. These instructions provide critical information about requirements that if overlooked could lead to disqualification of a Vendor's bid. All bids must be submitted in accordance with the provisions contained in these instructions and the Solicitation. Failure to do so may result in disqualification of a Vendor's bid.
- **2. MANDATORY TERMS:** The Solicitation may contain mandatory provisions identified by the use of the words "must," "will," and "shall" which identify a mandatory item or requirement. Failure to comply with a mandatory term in the Solicitation will result in bid disqualification.

All Vendors submitting a bid must attend the mandatory pre-bid meeting. Failure to attend the mandatory pre-bid meeting shall result in disqualification of the Vendor's bid. No one person attending the pre-bid meeting may represent more than one Vendor.

An attendance sheet provided at the pre-bid meeting shall serve as the official document verifying attendance. The State will not accept any other form of proof or documentation to verify attendance. Any person attending the pre-bid meeting on behalf of a Vendor must list on the attendance sheet his or her name and the name of the Vendor he or she is representing.

**5. VERBAL COMMUNICATION:** Any verbal communication between the Vendor and any State personnel is not binding, including verbal communication at the mandatory pre-bid conference. 6. - 14. UNIT PRICE: Unit prices shall prevail in cases of a discrepancy in the Vendor's bid.
- **15. PREFERENCE:** Vendor Preference may be requested in purchases of motor vehicles or construction and maintenance equipment and machinery used in highway and other infrastructure projects. Any request for preference must be submitted in writing with the bid, must specifically identify the preference requested with reference to the applicable subsection of West Virginia Code §5A-3-37, and should include with the bid any information necessary to evaluate and confirm the applicability of the requested preference. - 18. ELECTRONIC FILE ACCESS RESTRICTIONS: Vendor must ensure that its submission in wvOASIS can be accessed and viewed by the Property and Procurement Office staff immediately upon bid opening. The Property and Procurement Office will consider any file that cannot be immediately accessed and viewed at the time of the bid opening (such as, encrypted files, password protected files, or incompatible files) to be blank or incomplete as context requires and are therefore unacceptable. A vendor will not be permitted to unencrypt files, remove password protections, or resubmit documents after bid opening to make a file viewable if those documents are required with the bid. A Vendor may be required to provide document passwords or remove access restrictions to allow the Property and Procurement Office to print or electronically save documents provided that those documents are viewable by the Property and Procurement Office prior to obtaining the password or removing the access restriction.
- 19. NON-RESPONSIBLE: The Chief Procurement Officer reserves the right to reject the bid of any vendor as Non-Responsible in accordance with West Virginia Division of Natural Resources Series IV Purchasing Guidelines and Procedures §5.5.a., when the Chief Procurement Officer determines that the vendor submitting the bid does not have the capability to fully perform, or lacks the integrity and reliability to assure good-faith performance.
- **20. ACCEPTANCE/REJECTION:** The Agency may accept or reject any bid in whole, or in part in accordance with West Virginia Division of Natural Resources Series IV Purchasing Guidelines and Procedures §4.1. f. and §6.4. b.
- 21. YOUR SUBMISSION IS A PUBLIC DOCUMENT: Vendor's entire response to the Solicitation and the resulting Contract are public documents. As public documents, they will be disclosed to the public following the bid/proposal opening or award of the contract, as required by the competitive bidding laws of W. Va. Code §§ 5A-3-1 et seq., 5-22-1 et seq., and 5G-1-1 et seq. and the Freedom of Information Act W. Va. Code §§ 29B-1-1 et seq.
- DO NOT SUBMIT MATERIAL YOU CONSIDER TO BE CONFIDENTIAL, A TRADE SECRET(S), OR OTHERWISE NOT SUBJECT TO PUBLIC DISCLOSURE.

Submission of any bid, proposal, or other document to the Property and Procurement Office constitutes your explicit consent to the subsequent public disclosure of the bid, proposal, or document. The Property and Procurement Office will disclose any document labeled "confidential," "proprietary," "trade secret," "private," or labeled with any other claim against public disclosure of the documents, to include any "trade secrets" as defined by W. Va. Code § 47-22-1 et seq. All submissions are subject to public disclosure without notice.

**22. INTERESTED PARTY DISCLOSURE:** West Virginia Code § 6D-1-2 requires that the vendor submit to the Purchasing Division a disclosure of interested parties to the contract for all contracts with an actual or estimated value of at least \$1 Million. That disclosure must occur on the form prescribed and approved by the WV Ethics Commission prior to contract award. A copy of that form is included with this solicitation or can be obtained from the WV Ethics Commission. This requirement does not apply to publicly traded companies listed on a national or international stock exchange. A more detailed definition of interested parties can be obtained from the form referenced above.

**23. WITH THE BID REQUIREMENTS:** In instances where these specifications require documentation or other information with the bid, and a vendor fails to provide it with the bid, the Director of the Purchasing Division reserves the right to request those items after bid opening and prior to contract award pursuant to the authority to waive minor irregularities in bids or specifications under W. Va. CSR § 148-1-4.6. This authority does not apply to instances where state law mandates receipt with the bid.

  - e. "Property and Procurement Office" means the unit within the West Virginia Division of Natural Resources' Administration Section headed by the Chief Procurement Officer and its personnel.
  - f. "Director of the Purchasing Division" means the Director of the West Virginia Department of Administration, Purchasing Division.
  - g. "Award Document" means the document signed by the Agency and the Property and Procurement Office and approved as to form by the Attorney General that identifies the Vendor as the contract holder.
  - h. "Solicitation" means the official notice of an opportunity to supply the State with goods or services that is published by the Property and Procurement Office.

Any information provided in specification manuals, or any other source, verbal or written, which contradicts or violates the West Virginia Constitution, West Virginia Code or West Virginia Code of State Rules is void and of no effect.
- 21. COMPLIANCE WITH LAWS: Vendor shall comply with all applicable federal, state, and local laws, regulations and ordinances. By submitting a bid, Vendor acknowledges that it has reviewed, understands, and will comply with all applicable laws, regulations, and ordinances.

Any change to existing contracts that adds work or changes contract cost, and were not included in the original contract, must be approved by the Property and Procurement Office and the Attorney General's Office (as to form) prior to the implementation of the change or commencement of work affected by the change.
- 24. WAIVER: The failure of either party to insist upon a strict performance of any of the terms or provision of this Contract, or to exercise any option, right, or remedy herein contained, shall not be construed as a waiver or a relinquishment for the future of such term, provision, option, right, or

remedy, but the same shall continue in full force and effect. Any waiver must be expressly stated in writing and signed by the waiving party.

- 25. SUBSEQUENT FORMS: The terms and conditions contained in this Contract shall supersede any and all subsequent terms and conditions which may appear on any form documents submitted by Vendor to the Agency such as price lists, order forms, invoices, sales agreements, or maintenance agreements, and includes internet websites or other electronic documents. Acceptance or use of Vendor's forms does not constitute acceptance of the terms and conditions contained thereon.
- **26. ASSIGNMENT:** Neither this Contract nor any monies due, or to become due hereunder, may be assigned by the Vendor without the express written consent of the Agency, the Property and Procurement Office, the Attorney General's office (as to form only), and any other government agency or office that may be required to approve such assignments.
- 27. WARRANTY: The Vendor expressly warrants that the goods and/or services covered by this Contract will: (a) conform to the specifications, drawings, samples, or other description furnished or specified by the Agency; (b) be merchantable and fit for the purpose intended; and (c) be free from defect in material and workmanship.
- **28. STATE EMPLOYEES:** State employees are not permitted to utilize this Contract for personal use and the Vendor is prohibited from permitting or facilitating the same.
- **29. BANKRUPTCY:** In the event the Vendor files for bankruptcy protection, the State of West Virginia may deem this Contract null and void and terminate this Contract without notice.
- 30. PRIVACY, SECURITY, AND CONFIDENTIALITY: The Vendor agrees that it will not disclose to anyone, directly or indirectly, any such personally identifiable information or other confidential information gained from the Agency, unless the individual who is the subject of the information consents to the disclosure in writing or the disclosure is made pursuant to the Agency's policies, procedures, and rules. - 31. YOUR SUBMISSION IS A PUBLIC DOCUMENT: Vendor's entire response to the Solicitation and the resulting Contract are public documents. PURCHASING AFFIDAVIT: In accordance with West Virginia Code §5A-3-10a and 5-22-1(i), the State is prohibited from awarding a contract to any bidder that owes a debt to the State or to a political subdivision of the State. Vendors are required to sign, notarize, and submit the Purchasing Affidavit to the Agency affirming under oath that it is not in default on any monetary obligation owed to the State or a political subdivision of the State.
- 38. ADDITIONAL AGENCY AND LOCAL GOVERNMENT USE: This Contract may be utilized by other agencies, spending units, and political subdivisions of the State of West Virginia; county, municipal, and other local government bodies; and school districts ("Other Government Entities"). Any extension of this Contract to the aforementioned, Other Government Entities must be on the same prices, terms, and conditions as those offered and agreed to in this Contract, provided that such extension is in compliance with the applicable laws, rules, and ordinances of the Other Government Entity. If the Vendor does not wish to extend the prices, terms, and conditions of its bid and subsequent contract to the Other Government Entities, the Vendor must clearly indicate such refusal in its bid. A refusal to extend this Contract to the Other Government Entities shall not impact or influence the award of this Contract in any manner.
- 39. CONFLICT OF INTEREST: Vendor, its officers or members or employees, shall not presently have or acquire an interest, direct or indirect, which would conflict with or compromise the performance of its obligations hereunder. Vendor shall periodically inquire of its officers, members, and employees to ensure that a conflict of interest does not arise. Any conflict of interest discovered shall be promptly presented in detail to the Agency.

- 41. PREFERENCE FOR USE OF DOMESTIC STEEL PRODUCTS: Except when authorized by the Director of the Purchasing Division pursuant to W. Va. Code § 5A-3-56, no contractor may use or supply steel products for a State Contract Project other than those steel products made in the United States. A contractor who uses steel products in violation of this section may be subject to civil penalties pursuant to W. Va. Code § 5A-3-56. As used in this section:
  - a. "State Contract Project" means any erection or construction of, or any addition to, alteration of or other improvement to any building or structure, including, but not limited to, roads or highways, or the installation of any heating or cooling or ventilating plants or other equipment, or the supply of and materials for such projects, pursuant to a contract with the State of West Virginia for which bids were solicited on or after June 6, 2001.
  - b. "Steel Products" means products rolled, formed, shaped, drawn, extruded, forged, cast, fabricated or otherwise similarly processed, or processed by a combination of two or more or such operations, from steel made by the open heath, basic oxygen, electric furnace, Bessemer or other steel making process. The Purchasing Division Director may, in writing, authorize the use of foreign steel products if:
  - c. The cost for each contract item used does not exceed one tenth of one percent (.1%) of the total contract cost or two thousand five hundred dollars (\$2,500.00), whichever is greater. For the purposes of this section, the cost is the value of the steel product as delivered to the project; or

- 42. PREFERENCE FOR USE OF DOMESTIC ALUMINUM, GLASS, AND STEEL: In accordance with W. Va. Code § 5-19-1 et seq., and W. Va. CSR § 148-10-1 et seq., for every contract or subcontract, subject to the limitations contained herein, for the construction, reconstruction, alteration, repair, improvement or maintenance of public works or for the purchase of any item of machinery or equipment to be used at sites of public works, only domestic aluminum, glass or steel products shall be supplied unless the spending officer determines, in writing, after the receipt of offers or bids, (1) that the cost of domestic aluminum, glass or steel products is unreasonable or inconsistent with the public interest of the State of West Virginia, (2) that domestic aluminum, glass or steel products are not produced in sufficient quantities to meet the contract requirements, or (3) the available domestic aluminum, glass, or steel do not meet the contract specifications. This provision only applies to public works contracts awarded in amount more than fifty thousand dollars (\$50,000) or public works contracts that require more than ten thousand pounds of steel products.

The cost of domestic aluminum, glass, or steel products may be unreasonable if the cost is more than twenty percent (20%) of the bid or offered price for foreign made aluminum, glass, or steel products. If the domestic aluminum, glass or steel products to be supplied or produced in a "substantial labor surplus area", as defined by the United States Department of Labor, the cost of domestic aluminum, glass, or steel products may be unreasonable if the cost is more than thirty percent (30%) of the bid or offered price for foreign made aluminum, glass, or steel products.

#### **SPECIFICATIONS**

- 1. PURPOSE AND SCOPE: The West Virginia Division of Natural Resources is soliciting bids on behalf of the Parks and Recreation Section to establish an Open-End contract for propane at Holly River State Park. The contract will include equipment, installation, maintenance, fill and refill of propane tanks for the Park located at 680 State Park Road, Hacker Valley WV 26555 in Webster County.
- **2. DEFINITIONS:** The terms listed below shall have the meanings assigned to them below. Additional definitions can be found in section 2 of the General Terms and Conditions.
  - **2.1** "Contract Item" or "Contract Items" means the list of items identified in Agency 3.1 below and on the Pricing Pages.
  - **2.2 "OPIS"** means Oil Price Information Service as published by United Communications Group, 1300 Rockville Pike, Suite 1100, Rockville, MD 20852 1-800-929-4824.
  - 2.3 "Pricing Pages" means the schedule of prices, estimated order quantity, and totals contained in wvOASIS or attached hereto as Exhibit A, upon which Vendor should list its proposed price for the Contract Services.
  - **2.4** "Solicitation" means the official notice of an opportunity to supply the State with goods or services that is published by the West Virginia Division of Natural Resources.
  - 2.5 "The Park" means Holly River State Park.
  - **2.6** "Usage Requirements" means the amount of propane necessary for the operation of Holly River State Park.

#### 3. GENERAL REQUIREMENTS:

Contract Items and Mandatory Requirements: Vendor shall provide Agency with the Contract Items listed below on an open-end and continuing basis. Contract Items must meet or exceed the mandatory requirements as shown below.

- 3.1 On demand Vendor must provide and install: seven (7) five hundred (500) gallon tanks and nine (9) one hundred twenty (120) gallon tanks as set forth on the attached map *Exhibit B*.
  - **3.1.1** Tanks shall be set, but not affixed to concrete pad near the facility in which they will service.

- 3.1.2 <u>Vendor is responsible to the point where service enters the building.</u> Vendor must be responsible for all exterior equipment which includes tanks, lines and regulators to the building in which the tank serves.
  - 3.1.2.1 Contract must include service and maintenance of all supplies and equipment to the exterior of the facility that is serviced which includes tanks, lines and regulators.
- 3.1.3 The Park will be responsible for the interior equipment, which is defined as the interior gas lines, ranges, ovens, heaters, fireplaces, tank-less on demand water heaters and furnaces.
- 3.2 Usage of propane varies by demand due to weather conditions and park visitation. Usage is defined as propane sufficient to meet said demand.
- 3.3 Vendor must provide a twenty-four (24) hour emergency response number. Emergency response number must be affixed to the exterior of each tank and readily visible.
- 3.4 Vendor must place the facility on an "automatic fill" program. The object of the automatic fill program is to eliminate the need for Agency personnel to monitor fuel levels and place orders, while at the same time not running the risk of being without fuel. It is the intent of the Agency that "manual" orders of this type to be the exception and shall only be used in other than normal circumstances.
  - 3.4.1 Vendor must replenish the Parks fuel tanks automatically without an order being placed by the Agency personnel. Automatic refill schedule will be established once the Agency and Vendor have determined accurate delivery timeframes.
  - 3.4.2 Vendor is responsible for maintaining a program to have sufficient LP gas for use by the Park thus to minimize the possibility of emergency fuel deliveries. The Park will not pay additional fees for emergency fuel deliveries due to the Vendor's failure to provide sufficient LP gas.
- 3.5 The Vendor, along with assistance from the Park, will be responsible for the coordination of the changeover of exterior equipment with the current vendor. The changeover may consist of any existing tanks, transfer, replacement, etc. with the current vendor, to assure safe transfer in accordance with all Federal, State, County and local governing regulations and codes.
  - 3.5.1 Unused propane product removed during installation, and not transferred into any new Vendor tanks must be credited to Holly River State Park at the stated contract price. This procedure must be completed with a metered truck, written down and delivered to the Park office.

- 3.5.2 Tanks are to be in good condition, clean, painted white and have a valid recertification stamp. Tanks must be set per a schedule that will be provided by the Park in order to mitigate disruption of Park services. Vendor may not disrupt use by Park guests. Lines, regulators and devices as provided by the vendor must be free of defects or shall be repaired immediately.
- **3.5.3** Removal of equipment, and or supplies, shall be at no expense to the Park. Any damage or unsafe condition caused by removal must be repaired immediately and at no charge to the Park.
- 3.6 A winter additive, or sufficient sizing of regulator as provided by the Vendor for wintry weather to prevent lines from freezing, must be included for all tanks.
- 3.7 Vendors must provide proof of quality of the product provided at any time during the life of the contract. Such proof may include the identity and location of the refiner producing the fuel and the exact specifications/content of the fuel. Vendors must be an established refiner, distributor or dealer. In the event any adulterated or substandard fuel is delivered, all costs associated with the emptying and cleaning of Holly River State Park tank(s) will be the responsibility of the Vendor.
  - **3.7.1** Annual testing of the Vendor owned equipment consisting of valves, regulators, gauges, tanks and any other equipment to ensure proper operations shall be considered and documented by no later than the 15<sup>th</sup> of January each year.
  - 3.7.2 Replacement of defective equipment shall be done immediately at no additional cost to the Park. Proof of testing must be provided to the Park within thirty (30) days of said testing, at no additional cost to the Park. Testing results are subject to the approval of the Park.
- 3.8 Vendor will be responsible for securing ALL required governmental and jurisdictional permits required at no cost to the Park.
- 3.9 Vendor must be licensed with the state of West Virginia State Tax office as a refiner, distributor, or dealer for propane. Vendor should provide with their submitted bid response, a copy of their licenses. This documentation will be required before contract award.

#### 4. CONTRACT AWARD:

**4.1 Contract Award:** The Contract is intended to provide the Agency with a purchase price on all Contract Items. The Contract shall be awarded to the Vendor that provides the Contract Items meeting the required specifications for the lowest overall total bid amount as shown on *Exhibit A-Pricing Page*.

- **4.1.1** All prices quoted must be the delivered price to any location within Holly River State Park, 680 State Park Rd, Hacker Valley WV 26222 in Webster County.
- **4.1.2** Vendors must bid a "Firm Fixed Mark-Up Price" per gallon on fuel, inclusive of all delivery costs. The vendor is to be paid only a firm fixed mark-up for business profit and expenses in supplying product to the Park. Product price is tied to OPIS.
- 4.1.3 Product cost shall be the "Firm Fixed Mark-Up" Bid price plus the Oil Price Information Service (OPIS) weekly newsletter published price for the week proceeding delivery. OPIS is published by the United Communications Group, 11300 Rockville Pike, Suite 1100, Rockville, MD 20852. Telephone number: (800) 929-4824. Vendor shall be required to submit proof of cost in conduction with the submission of invoices. A copy of the page(s) showing the date and the cost will be acceptable.
- **4.1.4** In the event of an emergency, and because the Park has limited resources, the contract, terms and pricing remain in full force and effect. The Park is in a remote area, during such emergencies, priority to Holly River State Park must be maintained.
- 5. Pricing Pages: Vendor should complete Exhibit A-Pricing Page by filling all areas that are shaded. Vendor should complete the Pricing Page in its entirety, as failure to do so may result in Vendor's bids being disqualified.
  - \*\*<u>Vendor must identify the Terminal</u> which they are pulling their information from on their Bid Pricing Sheet-Exhibit A (Vendor Proposed Pull Terminal). \*\*
  - **5.1** Pricing Page contains a list of the Contract Items and estimated purchase volume. The estimated purchase volume for each item represents the approximate volume of anticipated purchases only.
    - Items 1 through 4: Estimated Tanks (multiplied by) Cost per Unit (equals) Extended Price. Total for Subtotal "A"
    - Item 5: Enter the name of the Proposed OPIS Pull Terminal.
    - Estimated OPIS Propane Index Price of \$2.67 (plus) Vendor Mark Up (equals) Unit Cost. (multiplied by) Estimated Quantity of 25,000 gallons (equals) Estimated Amount (Subtotal "B").
  - 5.2 No future use of the contract or any individual item is guaranteed or implied.

5.3 Vendor should electronically enter the information into the pricing page through wvOASIS, if available, or as an electronic document. Vendor can download the Excel version of the pricing page from the wvOASIS VSS website for this solicitation.

If submitting online, Vendor is to enter the TOTAL BID AMOUNT from Exhibit A-Pricing Page in the wvOASIS Commodity line when submitting bid response and include Exhibit A-Pricing Page as an attachment before submitting.

#### 6. ORDERING AND PAYMENT:

- 6.1 Ordering: Vendor shall accept orders through facsimile, e-mail, or any other written form of communication. Vendor may, but is not required to, accept on-line orders through a secure internet ordering portal/website. If Vendor has the ability to accept on-line orders, it should include in its response a brief description of how the Agency may utilize the on-line ordering system. Vendor shall ensure that its on-line ordering system is properly secured prior to processing Agency orders on-line.
- **6.2 Payment:** Vendor shall accept payment in accordance with the payment procedures of the State of West Virginia.
  - **6.2.1** Vendor must submit a separate invoice for each individual tank with the tank noted. Please see attached map (*Exhibit B*) for tank locations and sizes at the Park. Tanks should be identified on the invoice by describing the exact location of the tank and the size of the tank.
  - **6.2.2** Invoices must be itemized and cannot include items not covered under this contract.
  - **6.2.3** Vendor to provide, at invoice time, the meter of each tank before and after filling.
  - **6.2.4** A running total of each tank's demand is required and must be provided to the Park at no additional charge at the end of the contract.

#### 7. DELIVERY AND RETURN:

- 7.1 **Delivery Time:** Vendor shall formulate with the Park a delivery schedule to maintain adequate levels of LP gas. Vendor shall also be required to deliver propane upon demand.
  - **7.1.1** Vendor shall set up equipment and provide propane service within forty-five (45) days upon receipt of notice to proceed.
- 7.2 Late Delivery: Holly River State Park, under this Contract, must be notified by phone at the Park Office at 304-493-6353 and in writing if orders will be delayed for any reason.

Any delay in delivery that could cause harm to the Park will be grounds for cancellation of the delayed order, and/or obtaining the items ordered from a third party.

Any Section seeking to obtain items from a third party under this provision must first obtain approval of the Chief Procurement Officer.

- 7.3 **Delivery Payment/Risk of Loss:** Standard order delivery shall be F.O.B. destination to the Agency's location. Vendor shall include the cost of standard order delivery charges in its bid pricing/discount and is not permitted to charge the Agency separately for such delivery. The Park will not pay extra delivery charge for emergency orders, see *Section* 3.4.2.
- 7.4 Return of Unacceptable Items: If the Agency deems the Contract Items to be unacceptable, the Contract Items shall be returned to Vendor at Vendor's expense and with no restocking charge. Vendor shall make immediate arrangements for the return upon notification that items are unacceptable see Section 3.7. If the original packaging cannot be utilized for the return, Vendor will supply the Agency with appropriate return packaging upon request. All returns of unacceptable items shall be F.O.B. the Agency's location. The returned product shall either be replaced, or the Agency shall receive a full credit or refund for the purchase price, at the Agency's discretion.
- 7.5 Return Due to Agency Error: Items ordered in error by the Agency will be returned for credit within 30 days of receipt, F.O.B. Vendor's location. Vendor shall not charge a restocking fee if returned products are in a resalable condition. Items shall be deemed to be in a resalable condition if they are unused and in the original packaging. Any restocking fee for items not in a resalable condition shall be the lower of the Vendor's customary restocking fee or 5% of the total invoiced value of the returned items.

#### 8. VENDOR DEFAULT:

- **8.1** The following shall be considered a Vendor default under this Contract.
  - **8.1.1** Failure to provide Contract Items in accordance with the requirements contained herein.
  - **8.1.2** Failure to comply with other specifications and requirements contained herein.
  - **8.1.3** Failure to comply with any laws, rules, and ordinances applicable to the Contract Services provided under this Contract.
  - **8.1.4** Failure to remedy deficient performance upon request.
- 8.2 The following remedies shall be available to Agency upon default.

#### West Virginia Division of Natural Resources – State Parks and Recreation Holly River State Park – Open-End Propane Contract

- **8.2.1** Immediate cancellation of the Contract.
- **8.2.2** Immediate cancellation of one or more release orders issued under this Contract.
- **8.2.3** Any other remedies available in law or equity.

#### 9. MISCELLANEOUS:

- **9.1 No Substitutions:** Vendor shall supply only Contract Items submitted in response to the Solicitation unless a contract modification is approved in accordance with the provisions contained in this Contract.
- **9.2 Vendor Supply:** Vendor must carry sufficient inventory of the Contract Items being offered to fulfill its obligations under this Contract. By signing its bid, Vendor certifies that it can supply the Contract Items contained in its bid response.
- 9.3 Reports: Vendor shall provide quarterly reports and annual summaries to the Agency showing the Agency's items purchased, quantities of items purchased, and total dollar value of the items purchased. Vendor shall also provide reports, upon request, showing the items purchased during the term of this Contract, the quantity purchased for each of those items, and the total value of purchases for each of those items. Failure to supply such reports may be grounds for cancellation of this Contract.
- 9.4 Contract Manager: During its performance of this Contract, Vendor must designate and maintain a primary contract manager responsible for overseeing Vendor's responsibilities under this Contract. The Contract Manager must be available during normal business hours to address any customer service or other issues related to this Contract. Vendor should list its Contract manager and his or her contact information below.

#### **PURCHASING AFFIDAVIT**

**CONSTRUCTION CONTRACTS:** Under W. Va. Code § 5-22-1(i), the contracting public entity shall not award a construction contract to any bidder that is known to be in default on any monetary obligation owed to the state or a political subdivision of the state, including, but not limited to, obligations related to payroll taxes, property taxes, sales and use taxes, fire service fees, or other fines or fees.

#### **DEFINITIONS:**

"Debt" means any assessment, premium, penalty, fine, tax or other amount of money owed to the state or any of its political subdivisions because of a judgment, fine, permit violation, license assessment, defaulted workers' compensation premium, penalty or other assessment presently delinquent or due and required to be paid to the state or any of its political subdivisions, including any interest or additional penalties accrued thereon.

"Employer default" means having an outstanding balance or liability to the old fund or to the uninsured employers' fund or being in policy default, as defined in W. Va. Code § 23-2c-2, failure to maintain mandatory workers' compensation coverage, or failure to fully meet its obligations as a workers' compensation self-insured employer. An employer is not in employer default if it has entered into a repayment agreement with the Insurance Commissioner and remains in compliance with the obligations under the repayment agreement.

"Related party" means a party, whether an individual, corporation, partnership, association, limited liability company or any other form or business association or other entity whatsoever, related to any vendor by blood, marriage, ownership or contract through which the party has a relationship of ownership or other interest with the vendor so that the party will actually or by effect receive or control a portion of the benefit, profit or other consideration from performance of a vendor contract with the party receiving an amount that meets or exceed five percent of the total contract amount.

AFFIRMATION: By signing this form, the vendor's authorized signer affirms and acknowledges under penalty of law for false swearing (*W. Va. Code* §61-5-3) that: (1) for construction contracts, the vendor is not in default on any monetary obligation owed to the state or a political subdivision of the state, and (2) for all other contracts, that neither vendor nor any related party owe a debt as defined above and that neither vendor nor any related party are in employer default as defined above, unless the debt or employer default is permitted under the exception above.
